- 225,000 people in California with DD
- 73% live with parents
- 9% live in their own homes with SLS or ILS

Trends


- Low Income
- High cost of housing
- Young population with disabilities
- Increase in prevalence of autism (5,700 in 1994 to 27,000 in 2004)

- Olmsted decision

 - Independent living emphasized



Parents create housing alternative for disabled adult children

Baruch and Joyce Schur were out of options. They couldn't find anywhere for their physically and intellectually disabled 26-year-old son to live, at least nowhere that met their criteria or didn't have a yearslong waiting list.

The 55-year-old couple made plans to move out of the state. Uprooting themselves from their native Chicago, leaving friends and a family <u>business</u> ☑, was the only way to give Josh a home — not an institution — that



offered independence, a kosher kitchen and a sense of community before his parents

- Apartment or house bought or rented by parents
- Apartment or house bought or rented by a group of parents
- Independent Living Services centrally coordinated
- Rural House or Farm
- Intentional Community

Intentional Communities

Structure

- Typically requires nonprofit status
- Requires coordination with city and/or county
- Majority are farm/ranch communities
- Structure and size must be coordinated with support organizations.
- Community integration must be well thought out

Major Issues

- Type of home affects funding.
- Land /housing cost and fundraising are major issues
- Ongoing issues include staffing and continuity
